- (b) Financial Institution shall not change its name, its principal place of business or its chief executive officer without having given NEW CALHOUN AUTO AUCTION at least thirty (30) days prior certified written notice thereof;
- (c) Financial Institution acknowledges and guarantees that all vehicles sold through NEW CALHOUN AUTO AUCTION must be accompanied by a legal title, signed by an authorized representative, and include all supporting paperwork within thirty (30) days of sale as required by Georgia Law.

Financial Institution further agrees that any action it may bring against NEW CALHOUN AUTO AUCTION, for possession or non delivery shall be limited to the amount of purchase price of the vehicle, if accepted, less auction costs, and liquidated amount of one hundred dollars. Financial Institution further agrees that any action it may bring against NEW CALHOUN AUTO AUCTION, breach of warranty shall be liquidated amount of one hundred dollars. In any action brought by or against Financial Institution, Financial Institution specifically waives any claim for consequential damages.

Financial Institution submits to the jurisdiction of Gordon County, Georgia as to any action or proceeding arising out of or related to any legal or equitable claim which NEW CALHOUN AUTO AUCTION may have against the Financial Institution, including but not limited to the purchase or payment of automobiles from NEW CALHOUN AUTO AUCTION, and agrees not to bring action or proceeding arising out of or relating to any legal or equitable claim which NEW CALHOUN AUTO AUCTION may have against the Financial Institution including but not limited to the purchase or payment of automobiles from NEW CALHOUN AUTO AUCTION in any other court.
